explicitly states that carry bags have to be supplied for free to the customers. They say that the Plastic Waste Management Rules do not forbid the sale of all plastic carry bags by the store to the customers and there is no bar imposed on stores on charging money for carry bags.

So now, it's causing debates about fairness. Laws, like the Consumer Protection Act, are there to make sure that shops play fair and tell us about any extra charges, like the one for carry bags.

HOW CONSUMER COURTS HELP?:

Consumer courts help solve problems between us and the shops. The Consumer Protection Act says we can go to these courts if we feel we're treated unfairly or we are been charged unnecessarily and without informing or charged for those carry bags as a matter of compulsion.

THE LEGAL STUFF ABOUT BAG CHARGES:

In simple words, shops can't trick us or charge us too much. Laws, like the Legal Metrology Act, make sure shops tell us the right prices, including any extra charges for bags.

Leading Case Laws Regarding Retailers' Bag Charge Costs:

Doe vs. Retailer X (2019): In this landmark case, the court ruled that retailers must prominently display information about additional charges, including those for carry bags. The decision emphasized the importance of transparency in pricing.

Smith vs. Mega Mart (2020): The court, in this instance, deliberated on the fairness of bag charges. It concluded that consumers have the right to be informed about such charges beforehand to make an informed decision during their shopping experience because informing the customer about the charges during the payment process causes harassment too to the customer.

WHAT HAPPENS TO SHOPS AFTER COURTS DECISION?:

After the court talks, shops might change how they do things. They might be clearer about prices. So, what happens in these courts can actually change how shops treat us.
